Group Travel Odyssey Inc, its owners, directors, officers, employees and affiliates, the teacher chaperones and my local school, (collectively "GTO") does not own or operate any entity which is to or does provide goods or services for your trip including, for example, ownership or control over hotels or other lodging facilities, airline, vessel, bus, van or other transportation companies, local ground operators, providers or organizers of optional excursions or equipment used thereon, food service or entertainment providers, etc. All such persons and entities are independent contractors. As a result, GTO is not liable for any negligent or willful act or failure to act of any such person or entity, or of any other third party.

Terms and Conditions:

REFUND POLICY: A non-refundable deposit of \$250 per person is required to reserve a space. Your registration will not be processed until GTO receives the registration form along with a \$250 per person non-refundable check payment.

A payment reminder of your remaining balance will be sent prior to **February 9, 2018** (Final payment due date). If you pay in full at the time of your registration and must withdraw before the final payment due date (February 9, 2018), the initial \$250 deposit is still non-refundable. There will be NO refunds issued after the final payment due date (February 9, 2018).

I agree that GTO reserves the right to cancel a program for insufficient participation or for other reasons. In the event of such cancellation, I understand that my sole and exclusive remedy shall be to choose an alternative program offered by GTO or receive a full refund of monies paid to my school or to GTO for the event. I will not, however, be reimbursed for event preparation or other expenses.

If I wish to cancel my reservation in a GTO program, I must do so in writing. Withdrawal fees outlined on the application will apply. I have no right to a refund for any accommodations, meals or services I do not use.

VIDEO CAMERAS / PHOTOGRAPHY: Any film or video likeness taken of me while participating in a GTO program and any comments or statements made by me while participating in a GTO program may be used in future promotional or other materials published by GTO without payment of any consideration therefor.

LIABILITY: Without limitation, GTO is not responsible for any injury, loss, or damage to person or property, death, delay or inconvenience in connection with the provision of any goods or services occasioned by or resulting from, but not limited to, acts of God, acts of government, force majeure, acts of war or civil unrest, insurrection or revolt, strikes or other labor activities, criminal or terrorist activities of any kind, or the threat thereof, overbooking or downgrading of accommodations, structural or other defective conditions in hotels or other lodging facilities, mechanical or other failure of airplanes or other means of transportation or for any failure of transportation mechanism to arrive or depart timely or safely, dangers associated with or bites from animals, pests or insects, marine life or vegetation of any sort, dangers incident to recreational activities such as scuba diving, zip lining, snorkeling, paddle boarding, surfing, swimming, kayaking, sailing, canoeing, rafting, hiking, bicycling, rock climbing, sanitation problems, food poisoning, lack of access to or quality of medical care, difficulty in evacuation in case of a medical or other emergency, illness, epidemics or the threat thereof or for any other cause beyond the direct control of GTO.

I accept liability for any financial obligations I may incur or any damage or injury I may cause while I am participating in a GTO program.

All event participants shall observe all rules of safety and conduct as directed by the program director or teacher-chaperone. The program director and teacher-chaperones have absolute authority to expel any event participant whose actions or behavior are considered detrimental to the group's welfare or constitute a danger to the participant or others. No refunds shall be made as a result of such expulsion.

If I become ill or injured during the program, GTO will try to seek medical treatment for me at my or my parent's expense and/or arranging transportation for me at my or my parent's expense back to my home. If my program director or teacher-chaperone has incurred medical expenses on my behalf, I will reimburse him or her. GTO shall not be held responsible for any medical illnesses or injuries incurred by me nor for any action or inaction taken by GTO to assist me in obtaining medical treatment.

Our instructors are professionals working in the Entertainment Industry. Due to their high demand, we may have to replace an instructor. All replacements will be announced before the Class/Workshop. GTO has the right to substitute instructors, hotels, airlines or other suppliers of service, equipment, attractions, changes to the itinerary, timing of events, the departure and arrival times, cities/destinations listed. I agree to accept any such changes. No refunds will be made in the event of any changes to the itinerary occurring prior to or after departure.

I represent and warrant that I do not have any medical or other problems which would affect my program participation.

If I am a non-U.S. citizen, I understand that I am responsible for obtaining all appropriate passport and/or visas.

BINDING ARBITRATION. I agree that any dispute concerning, relating, or referring to this contract, the brochure, or any other literature concerning my event, or the event itself shall be resolved exclusively by binding arbitration in Orlando, Florida, according to the then existing commercial rules of the American Arbitration Association. Such proceedings will be governed by substantive (but not procedural) Florida law. The arbitrator and not any federal, state, or local court or agency shall have exclusive authority to resolve any dispute relating to the interpretation, applicability, enforceability, conscionability, or formation of this contract, including but not limited to any claim that all or any part of this contract is void or voidable.
